The District is pleased to provide you with the **water year 2022** Consumer Confidence Annual Water Quality Report. We want to keep you informed about the quality of water the District has delivered to you over the past year. Our goal is, and always has been, to provide you a safe and dependable supply of drinking water. The following report covers the Mountain Village, the Meadow Village including Sweet Grass Hills, South Fork, West Fork, Hidden Village and Town Center and also Aspen Groves and Lone Moose subdivisions. This report does not cover the Yellowstone Club, Moonlight Basin properties or Spanish Peaks Resort. Those are separate water systems.

The District routinely monitors for constituents in your drinking water according to Federal and State laws. We are pleased to report that our drinking water is <u>very safe</u> and meets or exceeds all federal and state requirements. The following tables show any detects (more than, 0.0 ppm) in our monitoring for the period of **January 1st to December 31st, 2022** that have been found. Although we have learned through our monitoring and testing that some constituents have been detected, the EPA has determined that your water **IS SAFE** at these levels. For constituents that are not monitored yearly, we have reviewed our records back to the last time the constituent was monitored.

Big Sky's remote and pristine setting eliminates many of the manmade potential water quality problems that plague more densely populated areas. However, all sources of drinking water are subject to potential contamination by constituents that are naturally occurring and/or man-made. Those constituents can be microbes, organic or inorganic chemicals, or radioactive materials. All drinking water, <u>including bottled water</u>, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. In the tables below you may find terms and abbreviations you are not familiar with. To help you better understand these terms, we have provided the following definitions:

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years.

<u>Action Level</u> - The concentration of a contaminant which, if exceeded triggers treatment or other requirements in which a water system must follow.

<u>Treatment Technique (TT)</u> - A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

<u>Maximum Contaminant Level Goal</u> - The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

<u>Maximum Contaminant Level</u> - The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

WATER SOURCES & CONTAMINANTS AND ANY VIOLATIONS

Our drinking water source is from 12 active groundwater wells. This water system includes the Mountain and Meadow areas, Cascade, Sweetgrass Hills, Hidden Village, Aspen Groves, Town Center, Southfork and West Fork subdivisions.

MCL's are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with your own service lines and home plumbing. The District is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested.
