This Water Connection Inspection Permit is issued subject to the following conditions:

- 1. A Water Connection Inspection Permit must be obtained from Spanish Peaks before any connection is made to the Spanish Peaks water system. AN APPROVED WATER CONNECTION INSPECTION PERMIT MUST BE MADE AVAILABLE AT THE JOB SITE UPON REQUEST.
- 2. The owner is responsible for the cost of the water service(s) from the building to the water curb stop at the property line.
- 3. All water curb stop shall be located by Spanish Peaks personnel with the best information available. The owner or their contractor is responsible for finding the water curb stop
- 4. All onnections to the SP public water system shall be to the water service curb stop at the lot line. If a water service curb stop has not been stubbed to the lot line, then the **Owner** will be responsible for the cost of installing a curb stop from the main line to the property line.
- 5. The contractor is responsible for maintaining all service line set back requirements to structures, lot lines, private wells, etc. Where applicable, the contractor and home owner are responsible for any variances needed to install a water service line.
- 6. All water services must be constructed and laid in accordance with the Montana Public Works Standard Specifications, or <u>any</u> other applicable regulations of Spanish Peaks including but not limited to the following specifications:
  - a. **Pipe Bedding-** 4 inches under lateral and 6 inches over lateral piping, using 1 inch minus <u>washed</u> bedding material is required.
  - b. Locate Wire- All water service lines must be installed with locate wire, #10 AWG insulated.
  - c. **Materials-** All water servic e lines shall be a minimum of 1 inch diameter and shall be class SDR-7, PE-3408 polyethylene pressure pipe **minimum 200 psi pressure rating**. Pipe shall be Phillips Driscopipe Ultra line 5100 or a Spanish Peaks approved equal.
  - d. **Accessibility-** All curb stops will be readily accessible at the completion of the project.
  - e. **Service lines-** All service lines shall be one continuous pipe from the curb stop to the house. No couplers will be allowed without written authorization from Spanish Peaks.
  - f. **Curb Stops**-All new curb stops must have a 2ft X 2ft concrete pad underneath the curb stop and must have foam board over the curb stop and water servvice line.
- 7. All water services must be inspected, tested and approved by a representative from Spanish Peaks prior to backfilling over the water services.
- 8. The water lateral contractor must have the site prepared safe for inspection and must give the District at least **TWO (2)** business day advance notice when the water service line is ready for inspection and connection to the water system.
- 9. In areas where groundwater conditions necessitate dewatering, the water service line contractor shall use appropriate dewatering equipment and comply with all local and state regulations. The water service line contractor shall **not** use any part of the sewer collection system for trench dewatering disposal.
- 10. The water service contractor is responsible for any damages, or disturbance to the public right-of-way and roads. Restoration of the public right-of-way and/or roads will be the responsibility of the water service contractor. The restoration work must be completed in a manner that is satisfactory to Spanish Peaks.
- 11. Water Connection Permits are valid for a period of **ONE YEAR** for most projects from the date of issuance. The water service line must be installed and inspected within the term of the permit, if they are not, the owner may file for a permit extension. If construction has not commenced within one year from the date of permit issuance, the permit will become null and void.
- 12. Sewer laterals and water service laterals shall not be laid in a common trench. At least 10 feet of separation must be maintained without prior approval of Spanish Peaks. If sewer & water lines cross, at least 18 inches of separation must be maintained.
